You are cordially invited to submit your fine art images for jury to the Thirteenth Annual Waupaca Arts on the Square, taking place on Saturday, August 17, 2019 from 10am to 4 pm *off the square* in beautiful downtown Waupaca, Wisconsin. This unique, eclectic festival of the arts, with an estimated 5000 attendees, celebrates all aspects of the arts, with a special emphasis on community participation. In addition to the 40 juried artists, a variety of diverse events take place throughout the festival weekend.

- **Annual Waupaca Triathlon:** Draws over 800 athletes, concurrent with the Arts on the Square

Eligibility:

Participation is open to all artists working in all fine art and fine art craft media. All work must be the artist's own and original in concept, design and execution. Artists whose work has been made with the use of commercial kits, molds, patterns or other commercial methods will not be accepted.

Jury Process:

Selection of work will be reviewed and judged by a panel of professionals and WCAB members. Selection is made based on originality, execution of design, technique and craftsmanship, creative use of materials, aesthetic qualities, and diversity of media within the Arts on the Square event.

Procedure:

Please send well-marked slides, photographs, CD, or e-mail with JPG attachments, or a URL to a website. *Do not send the actual works of art!* Images of accepted artists will be returned to the artist after review on the date of the event. Images for work that has not been accepted will be returned upon artist notification. Jury fee is nonrefundable.

Deposit of check:

Your application fee check will be deposited upon receipt for security purposes and to ensure proper accounting. Deposit of check does not imply acceptance to Arts on the Square. If an artist's work is not accepted, the registration fee will be returned along with artist notification.

Booth spaces and Fees:

Booth spaces are 12'x13', and will easily accommodate the standard 10'x10' tent. You will be assigned a space. All spaces surround the Waupaca downtown Square, amidst a variety of activities. This is an all-weather event.

Awards:

There will be a total of \$750 cash awards granted, including Best of Show, and 5 Awards of Excellence which are determined by a professional panel and selected on overall work, quality and presentation.
